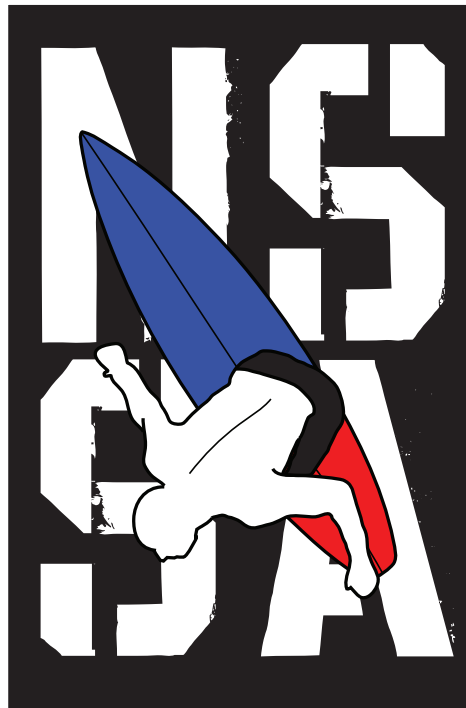

How to compete in the NSSA COLLEGE TEAM Season

- 1. EACH TEAM MEMBER MUST PAY THE \$70.00 NSSA MEMBERSHIP FEE. This fee is not included with the team entry fee. You must go online and pay for membership nssa.org before you can surf in any NSSA event. Nationals and State Championships are not included with the team payment.
2. Mail entry blank and fee(s) to reach the NSSA office by 12:00 Noon the Wednesday before the event your team wants to enter.
3. There are no refunds once a team has entered.
4. Competitors and teams will receive ratings on an accumulative basis.
5. You must stay for the awards ceremony to pick up your trophy or have someone pick it up for you or you will not receive one.
6. All competitors may call the office at the below number after 3:00 p.m. on the Friday before the event to get directions and an order of events.
7. College competitors (academic guidelines): It is the competitor's responsibility to know and understand NSSA competition rules and academic requirements.
8. Each team is made up of 6 shortboarders, 2 women, and 1 long-boarder
9. If you bounce a check, you will be required to pay the NSSA in cash or money order \$25.00 plus the amount of the check that bounced.

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and, 3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and, 4.
