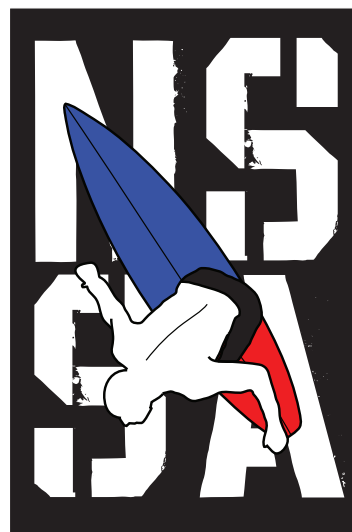

## How to compete in the NSSA Southeast OPEN/EXPLORER Seasons

1. YOU MUST PAY THE NSSA MEMBERSHIP FEE. This fee must be paid online at [www.nssa.org](http://www.nssa.org) and will cost \$70.00.
2. Mail entry blank and fee(s) to reach the NSSA office by 12:00 noon the Wednesday before the event you wish to enter. NO PHONE ENTRIES WILL BE ACCEPTED!!
3. There are no refunds. Only transfers are permitted if you submit a doctors note.
4. Competitors in all divisions will receive ratings on an accumulative basis. Competitors who are prominently rated will be invited to compete in the NSSA EAST COAST CHAMPIONSHIPS and the NSSA NATIONAL CHAMPIONSHIPS. See 2008/09 rule book for NSSA East Coast/National Championship qualifications and requirements.
5. Each competitor must surf at least 50% plus 2 events in order to qualify for the East Coast Championships and Nationals.
6. Each additional division entry is an extra \$30.00.
7. All competitors should check the website hotline at the below web address after 6:00pm on the Friday before the event to get updated contest information.
8. Open/Explorer Season Academic Requirements: Open Season competitors must be full time students and maintaining a minimum 2.0 G.P.A. Explorer Season Competitors 18 and under must be a full time student maintaining a minimum 2.0 G.P.A. or show completion of High School.
9. It is the competitors responsibility to know and understand NSSA competition rules and academic requirements. NSSA rule books are included with membership packets or can be obtained from your Conference Director or the NSSA National Office.
10. If you bounce a check, you will be required to pay the NSSA in cash or money order \$25.00 plus the amount of the check that bounced. If you bounce more than one check, only cash or money orders will be accepted.
11. Some events may have to be postponed to later dates. While we do try to avoid any conflicts with other contests, sometimes it is inevitable. Especially when there is lack of surf or extreme weather conditions. Always check the NSSA Hotline at the below address for updated contest information.

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation.
