How to compete in the NSSA Southeast/North College Season

- 1. YOU MUST PAY THE NSSA MEMBERSHIP FEE. This fee can either be paid online at nssa.org and will cost \$70.00 or you can send it in with your entry and it will cost \$80.00.
2. Mail entry blank and fee(s) to reach the NSSA office by 12:00 noon the Thursday before the event you wish to enter. NO PHONE ENTRIES WILL BE ACCEPTED!!
3. There are no refunds. Only transfers are permitted if you submit a doctors note.
4. Competitors in all divisions will receive ratings on an accumulative basis. Competitors who are prominently rated will be invited to compete in the NSSA EAST COAST CHAMPIONSHIPS and the NSSA NATIONAL CHAMPIONSHIPS. See 2009/10 rule book for NSSA East Coast/National Championship qualifications and requirements.
5. Each team entry is \$220.00. If your team beach enters, the fee is \$250.00
6. All competitors should call the office at the below number after 6:00 p.m. on the Friday before the event to get updated contest information.
7. College Season Academic Requirements: Competitors must be taking at least two academic classes to be eligible to compete and maintaining a minimum 2.0 G.P.A.
8. Team makeup: 6 shortboarders, 2 women, 1 longboarder.
9. It is the competitors responsibility to know and understand NSSA competition rules and academic requirements. NSSA rule books are on the NSSA web site.
10. If you bounce a check, you will be required to pay the NSSA in cash or money order \$25.00 plus the amount of the check that bounced. If you bounce more than one check, only cash or money orders will be accepted.
11. Some events may have to be postponed to later dates. While we do try to avoid any conflicts with other contests, sometimes it is inevitable. Especially when there is lack of surf or extreme weather conditions. Alway call the NSSA Hotline at the below number for updated contest informtion.
