### YOU MUST REGISTER FOR 2025/26 NSSA EAST COAST MEMBERSHIP IN ORDER TO COMPETE

#### **THE 2025/26 NSSA EAST COAST MEMBERSHIP FEE MUST BE PAID ONLINE ON THE WEBSITE AT NSSA.ORG. FEES ARE \$120.00 PER MEMBER**

1. Mail entry blank and fee(s) to reach the NSSA office by the Thursday before the event you wish to enter. NO PHONE ENTRIES WILL BE ACCEPTED!! If your entry form and fees do not reach the office by the Wednesday before the event you wish to enter, you will have to pay the late entry fee if you want to enter that event.
2. There are no refunds. Only transfers are permitted if you submit a doctor's note.
3. Competitors in all divisions will receive ratings on an accumulative basis.
4. Competitors who are prominently rated will be invited to compete in the NSSA EAST COAST CHAMPIONSHIPS and the NSSA NATIONAL CHAMPIONSHIPS. See 2025/26 rule book for NSSA East Coast/National Championship qualifications and requirements.
5. Each additional division entry is an extra \$25.00  
Open Season Academic Requirements: Competitors must be a full-time student maintaining a minimum 2.0 G.P.A.
6. It is the competitor's responsibility to know and understand NSSA competition rules and academic requirements. The NSSA rule book is available online.
7. If you bounce a check, you will be required to pay the NSSA in cash or money order \$30.00 plus the amount of the check that bounced. If you bounce more than one check, only cash or money orders will be accepted.
8. Some events may have to be postponed to later dates. While we do try to avoid any conflicts with other events, sometimes it is inevitable. Especially when there is lack of surf or extreme weather conditions. Always call the NSSA Hotline at the number below for updated contest information.
